ADMISSION REQUIREMENTS

In addition to the general requirements for admission to the Oklahoma State University Graduate College, the program requires:

- ▷ A minimum undergraduate GPA of 3.0
- ▷ GRE score of at least 280 (combined) or a MAT score of at least 394
- ▷ GRE or MAT test scores completed within the past five years
- ▷ Three letters of reference (preferably from previous instructors or employers)
- ▷ A statement of professionally related experiences and goals: Approximately two typed pages (double spaced) emphasizing the applicant's pertinent personal, educational and professional experiences, and setting for the applicant's professional aspirations as related to this Master's degree
- ▷ Current and complete resume/vita
- ▷ TOEFL or IELTS (if required to establish English proficiency)

PROVISIONAL ADMISSION

Provisional admission may be granted for one semester if one of the minimum background requirements is not met.

Provisionally admitted students may be granted full admission after completing the conditions of provisional admission stated on the acceptance letter and approval of the area. Provisionally admitted master's students must receive a 3.5 GPA for the first nine credit hours taken.

APPLICATION DEADLINE

Applications are accepted for enrollment each semester. Fall and spring semesters have a priority deadline. Completed applications received prior to the priority deadline will be reviewed before the final deadline. "Priority" applicants will receive notification of acceptance/rejection prior to the final deadline.
